Subcontractors are defined as individuals, partnerships, corporations or other organizations in the business of subcontracting labor and/or materials for building construction projects at the jobsite or for public improvement projects.

Associates are defined as individuals, partnerships, corporations or other organizations engaged principally in the manufacture or sale of materials, equipment and/or services used by contractors and subcontractors engaged in construction and/or who employ personnel directly connected with the construction industry, or those whose activities are related to the construction industry.
